Please read through the following statement carefully. It is important that all parents/guardians fully understand all items below. If you have any questions or concerns, please call the school office at 216-481-6824.

- *Our Lady of the Lake School is a Catholic school established by Our Lady of the Lake Parish to serve the children of the parish and whenever room is available, children of the surrounding area.
- *The purpose of Our Lady of the Lake School is to achieve academic excellence grounded in Catholic faith and values through the traditions of the Roman Catholic Church.
- *All students attending Our Lady of the Lake School, regardless of faith tradition, are required to take religion and to participate in faith formation activities and liturgical celebrations. It is not the intention of Our Lady of the Lake School to convert non-Catholic students to Catholicism, but rather to educate students about the Catholic faith and to allow them the opportunity to experience faith formation with the Our Lady of the Lake community. In light of this, students are not excused from religion class or from faith formation experiences.
- *Our Lady of the Lake School is a non-profit institution that is funded through the tuition payments, government grants, independent grants, and parish subsidy. All families are required to meet all requirements and obligations on time.
- *All families receiving the Educational Choice (EdChoice) Scholarship or the Jon Peterson Scholarship need to meet all requirements and obligations on time.
- *All families are responsible for viewing the Our Lady of the Lake School Family Handbook online annually and are responsible for reviewing it with their Our Lady of the Lake students. Parents/guardians and students must sign the Educational and Conduct Contract and submit it to the school by the designated deadline.
- *All families are obligated to follow the policies and procedures established by Our Lady of the Lake School. This includes the completion of all forms and their submission as directed by the school.
- *Our Lady of the Lake School regularly publishes a school newsletter. It is the responsibility of every family to read the newsletter and other school communications in order to remain informed. The school newsletter, as well as other parish information is routinely posted on the school website and Digital Academy. Digital Academy is our on-line communication system. The Our Lady of the Lake School Digital Academy account is exclusive of all other institutions. All parents are required to establish a Digital Academy account. There is no financial obligation for establishing a Digital Academy account.
- *Students are admitted to Our Lady of the Lake School on an annual basis. All students must reapply for enrollment annually. In order to be considered for re-enrollment ahead of incoming students, the parents/guardians of currently enrolled students must meet the registration application deadlines and resolve all financial obligations.
- *Only those students whose families completed all registration procedures will be considered for enrollment.
- *The administration of Our Lady of the Lake School reserves the right to determine eligibility for enrollment of any and all students.

Our Lady of the Lake School admits students of all races, nationalities, or ethnic origins to all rights, privileges, programs, and activities. Our Lady of the Lake welcomes students of all faiths.
